### ***OPEN MEETING***

The annual meeting of the Board of Directors of the Cheverly Swim and Racquet Club will take place at the Cheverly Community Center on **Thursday December 3, 2015 at 7:00 P.M.** All members are encouraged to attend. The 2016 Draft Budget will be discussed and approved by the Board following the open meeting. Please see the notice below regarding the budget for the new year.

### ***2016 DUES***

**THANK YOU** to all of our members for their continued support in paying your dues on a timely basis. There are huge upfront costs to get the pool open which must be paid well in advance of the time that your dues must be paid to the pool- which is before May 1. Members who pay their dues late cause financial hardship for the pool.

Please note that late fees for 2016 will continue at \$100 for all dues not paid in full prior to 5/1/2016. We will continue to offer the \$10 early payment discount (if paid prior to 4/1/2016) and the \$25 senior citizen discount as applicable for dues paid on time. This discount can only be taken when the senior citizen is the pool member, not just a family member. As always, unpaid memberships will be denied access to the Club until dues (and the \$100 late fee) are paid in full. We will be sending paper invoices with the exact dates and amounts to all members in early March 2016 (separate from the newsletter). If you intend to resign, please do so by sending a signed letter via snail mail to the pool's address at your earliest convenience.

### ***2016 BUDGET***

At this time, the Board is considering a dues increase to deal with several necessary improvement projects that have been deferred for several years. The Board will discuss the idea of a dues increase or a special assessment at its October meeting. Members of the Board are identifying several projects that need to be addressed – and will prioritize that list to coordinate those projects that will be undertaken over the next several years.

Please note the FY2016 budget has not yet been completed. The fiscal health of the pool remains strong and the pool realized a profit this year despite projecting a loss for FY2015. Currently the draft budget does project a deficit, which is the reason that a dues increase is being considered as is a possible special one-time assessment to deal with our long list of projects.

The FY2016 budget will be made available prior to the Open Meeting in December – in an email to the membership, as well as being posted to the pool website at [www.cheverlypool.com](http://www.cheverlypool.com).
