Dear Members,

To assist with the timely payment of 2018 dues, we are sending this letter along with a pre-addressed envelope for your payment by check. **Please return the completed form(s), even if you pay online.**

Please return the enclosed Dues Letter form(s) no later than May 1, 2018. You may send a check with the form or use your bank's bill pay option to pay online. Either way, the Dues and Membership form must be sent for complete processing of your dues submission.

Thank you for paying your dues on time. We strive to get all the information entered into the database so everyone can enter the pool, hassle free. Your timely payment affords us the time we need to make this happen.

Mail the complete the included **Dues and Membership Form** to CSR, Attn: Sunshine Whiting, 5600 Euclid St., Cheverly, MD 20785.

- Full and Seasonal Membership dues remain at \$550.
- Childcare provider fees \$200, and \$75 for each non-member child in that provider's care.
- Senior Citizen, ages 55 or older may deduct \$25 from the dues.
- Payments made after May 1, 2018 will be assessed a \$100 late fee.
- Dues may be paid by check, payable to "Cheverly Swim and Racquet Club," and mailed with the completed Dues and Membership Form.

OR

Dues may be paid using your bank's bill pay option AND the completed Dues and Membership Form sent to CSR.

- **Dues payments will not be accepted at the Front Desk -- even after the pool opens for the season!**
- Members whose payments are postmarked or made by **May 1, 2018** may use the Club on Opening Day. Entry on Opening Day is not guaranteed if payment is not received before May 1, 2018.
- Resigning members should do so as soon as possible, but no later than May 31 to receive their maximum equity balance. The bylaws state that equity deductions take place on June 1 and that resignations must be made in writing, with an original signature. The included Dues and Membership form should be signed and mailed to CSR, attn: Sunshine Whiting, 5600 Euclid St., Cheverly, MD 20785. Once your resignation is received, you will receive your equity check within 30 - 90 days.

2018 CHILD CARE PROVIDER REQUEST FORM

The Club permits child care providers employed by members to use the Club upon payment of a seasonal fee. Use of the Club by child care providers is a privilege, and the Club reserves the right to reject a request for any reason. Members are responsible for ensuring that their child care provider adheres to the Club's Operating Rules. Violations of the Rules by child care providers may result in the suspension, loss of use or loss of membership privileges by the child care provider and/or the member.

In 2008, the Board adopted a policy allowing child care providers to visit the pool alone (*i.e.*, without members) on **non-holiday weekdays only**. This policy remains in effect. **Child care providers may not bring guests to the Club at any time.**

The child care provider fee for 2018 is again \$200. The fee is not pro-ratable or refundable and may be used only for a single child care provider. Child care providers may bring other non-member children in their care to the Club for a seasonal fee of \$75 per child.

Your child care provider will not be admitted to the Club unless this form has been submitted at least one week before the anticipated entrance to the Club.
