Dear Members,

To assist with the timely payment of 2017 dues, we are sending this letter along with a pre-addressed envelope for your payment by check.

Timely collection of dues is crucial to the Club. We depend on dues to meet our significant early season operating expenses. Processing dues payments and updating our membership records require considerable time. For these reasons, the Board is again requiring that dues payments be **postmarked or made via PayPal by May 1, 2017**. Payments after that date are subject to a \$100 late fee.

- Dues remain at \$550 for Full and Seasonal members and an additional \$200 for childcare providers and \$75 for each non-member child. The senior citizen and early payment discounts are the same as last year. A \$100 late fee will be assessed after May 1, 2017.
- Dues may be paid by check or PayPal (via [www.cheverlypool.com](http://www.cheverlypool.com)). Make checks payable to “Cheverly Swim and Racquet Club” and mail to the address below. **Payments will not be accepted at the Front Desk -- even after the pool opens for the season!**
- Please complete the enclosed **2017 Dues and Membership Form** and include it with your check.
- Members whose payments are postmarked or made via PayPal by **May 1, 2017** may use the Club on Opening Day. Entry on Opening Day is not guaranteed if payment is postmarked or made after May 1, 2017.
- To members resigning in 2017: please submit the enclosed form as soon as possible, the bylaws require resignation notification in writing. You will receive the appropriate equity payment upon your resignation. This will allow us to notify the next family on the waiting list before the summer begins.
